TOURIST INFORMATION

Lignano Sabbiadoro

Lignano Sabbiadoro is one of the most famous seaside resorts of Italy's north-east region: it has about 6000 inhabitants and is located in the district of Udine, on a peninsula near the mouth of the **Tagliamento River**, between the open sea and the **Lagoon of Marano**.

Lignano be called an oasis of relax and entertainment: its 8 kilometers of fine golden beaches receives since several years the prize called "Blue Flag" for environmental protection. The area of Lignano, in fact, contains three locations:

- **Lignano Sabbiadoro**, a city full of thousand restaurants, outdoor bars and stores;
- **Lignano Pineta**, rich of gardens and designed with elegant boulevards;
- **Lignano Riviera**, the most relaxing location, surrounded by beautiful pine trees.

The place name comes from **lupignanum**, which means "place inhabited by wolves". Indeed, despite early documents relating to the village date back to the visit of the Patriarch of Grado Elijah, the history of the area has much more distant origins. Lignano in Roman times was probably crossed by **Via Annia** as evidenced by the discovery, by some fishermen, numerous stones from the roadway. In the **Middle Ages** the territory came under the supremacy of Aquileia and then be transferred to the County of Gorizia.

Lignano in 1420 came under the dominion of the **Venetian Republic** that gave it in fief to various noble families. Among these, the family Vendramin he built in the mid 1500s, the church of S. Zechariah, who physically marked on the possession of the Vendramin Lignano.

In 1542 the village was equipped with then existing fortifications by the Patriarch Grimani, but the raid provoked the destruction of the Venetian fortress. Under Napoleon, a second fort was built to defend the continental blockade declared against England. Until the early twentieth century Lignano Sabbiadoro remained a small group, only through tourism resort is one of the stations have become tourist destinations.

Very rich **vegetation** that characterizes the region around Lignano: oaks, pines blacks, lime, siberian elms, birches, horse chestnuts and plane trees form a lush pine forest that borders the eight kilometers of sandy **beach**.

In Lignano you beach sports through sports centers with excellent **sailing** and **windsurfing** instructor.

It **rides** and play beach **volleyball**. The **Golf Club** 18 holes, open all year, then offers one of the most attractive routes between those overlooking the sea. **Cycling** itineraries between scented pine forests and charming views of the lagoon. And to pamper yourself a bit ', you will appreciate the modern **thermae**.

The Village Ge.Tur. of Lignano Sabbiadoro, comprises several residences, is a modern tourist - social resort immersed in 60 hectares of verdant pine forest surrounded by trees: is a perfect place for spending wonderful days with your dogs.

The tranquility, the aroma of fragrant pines, the wonderful sea and the private beach of the village (1120 x 60 m.), create the ideal atmosphere for an relaxed holiday.

The picnic area is crossed by 12 km of internal roads, without cars: it's a perfect place for walking and doing every kind of sport.

"GE. TUR." VILLAGE REGULATION

1. For the safety of our guests and to forbid the illegal and improper entrance into the Village of any unauthorized person, during the registration will be given a colored bracelet that every authorized person has to wear: the bracelet has to be considered personal and not transferable; has to be showed at the entrance and when the staff will ask it.
2. Only the guests of the Village are allowed to park in defined areas: the parking is not supervised during the night. The staff reserves the removal of vehicles and / or other parked vehicles out of the defined areas.
3. Is not permitted to leave the dogs in the car if the car is not properly ventilated.
4. The entry and exit from the village (by car or by foot) is allowed only through the main gate at Reception from 6.00 am to 24.00. From 24.00 till 6.00, the entry and exit from the village, is permitted only by foot through the walkway.
5. The entrance to the Village of visitors during the event of DOG is allowed after giving a valid ID at the Concierge: the visitor will be provided by a special bracelet.
6. The visitor has to pay the daily ticket.
7. **Is not allowed to visitors and guests to enter in the Village with the car.**
8. **The Dogs entrance is permitted only if: they are more than 6 months up, they have immunization and prophylaxis against rabies made at least 40 days before the event.**
9. **Is not allowed the entrance of visitors who have a dog in heat** (for the visitor's dogs are valid the same rules of participants' dogs (see: Rules Dog Olympic Games - premise).

10. All the structures present in the village, the furnishings in the rooms, common areas and the beach must be respected. Is forbidden the use of electric stoves and open flame inside the village. Any damage caused by guests will be charged immediatly and payed before the departure.
11. **Is forbidden to consume packed lunches in the park, on the beach and in the structures of the village.**
12. Is not allowed to enter in the restaurant and in the Church with inadequate clothes.
13. During relaxing time inside the structures of the village (from 13.00 to 16.00 and from 22.30 to 8.00) is forbidden the use of audiovisual equipment and stereo. During the relaxing time, within the structures and outside in the park, the visitors have to respect others relax.
14. Minors must be accompanied by parents or persons expressly authorized by parents. Adults are fully responsible for children and their behavior inside the village: in particular, they have to pay attention to:
 - a. not disturb the other guests of the Village
 - b. assume responsibility of the children's activities in the swimming pool and in the park.
15. Since every room has its defined place on the beach, the management reserves the right to accept proposals of changing only for right reasons and only in the presence of free places on the beach.
16. In the price of the holiday in the village is included the use of the room and meals (breakfast, lunch and dinner) . The non-consumption of meals does not entitle to ask any kind of refund.
17. **During the breakfast or lunch or dinner time is forbidden to drink beverages buyed out of the Village.**
18. Inside the Village there is a trained personnel that has the task of monitoring guest's compliance in the respect of the present General Settlement.
19. The use of sports facilities and swimming pools for people inside the village is permitted only in accordance with the organization. The access to the Olympic Pool is forbidden for dogs: otherwise guests can access but only by prior arrangement when booking. The fee is not included in the price of the holiday in the village. The entrance ticket to the swimming pool can be bought at the reception.
20. At the moment of registration to each guest is given an identification bracelet that the guest has to wear for all his stay in the village. The bracelet is personal, non-transferable.
21. The only entrance of the Village is the one situated in Viale Centrale 29. From 24.00 hours until 06.00 hours is not allowed to enter and exit the village with cars. **Is strictly forbidden to enter or stay in the village with campers, caravans and roulotte.**

Visitors

The daily ticket for the entrance in the village costs € 15.00 per person. The 3day-ticket for the entrance in the village for every day of the event costs € 30.00 per person. Thanks to ticket the visitor have:

- Pedestrian access to the village;
- Participation in events (excluding SCIVAC seminar)
- Entrance to the Palazzetto for the final and closing ceremony (on Sunday, Oct. 17).

If the visitor buy the 3day-ticket he will participate to the draw for a trip for 2 people for 7 days on the Red Sea.

The children, accompanied by parents, from 0-14 years of age enter for free but they will not receive tickets for the extraction.

Buying a ticket does not allow access to beach, restaurants and extra if not included in this Regulation.

DOG OLYMPIC GAMES® REGULATION

Premise

In all CSEN events dog's welfare is the priority.

1. The area where the event takes place is fenced and can be accessed only from the entrance of the Village that is controlled by our security staff.
2. Accreditation is subjected to veterinary medical supervision. Veterinarians have a responsibility to control that all dogs of the event are more than 6 (six) months old, are healthy and are provided with medical records in compliance with the mandatory vaccinations and the vaccination against rabies, as required by existing ordinances and regulations of the Ministry of Health. Once satisfied that requirement will be given a clearance that allows the accreditation.
3. If the tenant of the dog has forgotten health certificate, he may complete a form of self and therefore he can continue the registration.
4. If a person hasn't got both health card and certificate he cannot stay in the village (and he cannot ask money back).
5. Dogs under the age of 9 (nine) months cannot enter the village, in any case.
6. Dogs are not allowed to be lead with choke collars or any other means of coercion (electric collar or collar with spikes, etc.) and the entrance in the village it's forbidden for females in an advanced state of pregnancy or lactation, etc..
7. Is allowed access to females in races only if inscribed in the following disciplines: Dog Agility, Fly Ball and Disc Dog. They will race for last in their class registration. Can not be conducted for any reason on the fields of other disciplines.
8. **The aggressive dogs cannot participate at DOG.**
9. During the races is not allowed to athletes competing to show their personal sponsors. The commercial code, attached to the dog's name, can not appear during the Cino-Olympic Games.
10. Every viewer who want to enter in the Village with the dog has to pass the medical examination.
11. Are excluded from the races sick dogs and clearly lactating females.
12. Outside the fenced areas where competitions take place, dogs **must be** kept strictly on a leash.

13. Are not tolerated attitudes of coercion and abuse, even verbal, to the dog.
14. Tenants and visitors with dogs are required to collect their dogs' droppings around the village, including parks and beaches, and throw them in the containers.
15. Security staff and volunteers are responsible for compliance with this general settlement. If someone will not observe the rules written here he will be disqualified.
16. The visitors who'll not collect their dogs' droppings will be accompanied exit.
17. the entrance in restaurant areas is forbidden for dogs.
18. All competitors and the visitors are invited to keep a polite behavior.
19. It is obligatory to show dog's documents every time the staff require them.

REGISTRATION and ACCREDITATION

Registration for Dog Olympic Games® is available with the forms realized for each discipline.

The forms must be filled only with the PC and sent by mail, accompanied by the receipt of payment.

Forms not completed, completed by hand, without acknowledgment of contextual payment will be trashed without any notice and the competitor will not be entitled to any refund.

The closing date for tenders is **31.07.2010** without application of surcharges.

From **31.07.2010** since **31.08.2010** will be extra-price of 30%; from **01.09.2010** since **15.09.2010** be extra-price of 50%.

At the moment of the accreditation is required to present a copy of the registration form, or forms if more dogs were registered, the email confirmation and the receipt of payment.

At the reception of the Ge.Tur. Village is required to present identity documents and documents for the dog / s (health card) which will be verified by DOG's staff.

After registration formalities the guests can enter in the Village by car.

The process of accreditation is required for the actual recording to bids for removal of the race kit and medical health.

Each conductor will be present at the control with the dog / s documents. The health inspection and accreditation must be made by the holder of the dog. Coaches and club leaders cannot check themselves health inspection and accreditation.

COMPETITION'S AREAS

- Can not stay inside the competition's areas if asked to wait in the pre-ring
- **Agility Dog and Tunnel Cup (in the plan of the Village marked with the letter A)**
For the Agility Dog is used a football field with synthetic grass, sizes: 104,70 m. x 66,80 m. And it will be converted into 2 camps where it's possible to play simultaneously. The synthetic grass "Prestige" guarantees: the elasticity of the land and the absolute permeability, the optimal use of the field in all weather conditions. The field is illuminated with four lighting towers of 21.50 meters high with 24 lights, 2000 watts.
- **Dog Dance (Olympic Pool Complex, in the plan of the Village marked with the letter P4)**
Indoor. At the first floor, will take place Dog Dance's competitions: there is a large room of 1000 square meters, equipped with audio-Dolby 5.1 surround sound and big screen projection system. A director workstation provides maximum functionality for shooting and transmitting audio. The room is equipped with fiber connections and air conditioning.

- **Obedience (external field, in the plan of the Village marked with the letter F)**
Measures 19 x 32 meters. Fenced and lighted paved with "Spontex" (rubber on asphalt). Its flexibility assures quality and safety.
- **Rally Obedience (external field, in the plan of the Village marked with the letter C)**
Measures 18.30 x 36.30 meters. Synthetic grass. Fenced, paved with turf. Its flexibility assures quality and safety.
- **Fly Ball (external field, in the plan of the Village marked with the letter D)**
Measures 22 x 44 meters. Synthetic grass. Fenced, paved with turf. Its flexibility assures quality and safety.
- **Swimming and Carry (outdoor pool, in the plan of the village is marked with the letter P2)**
Olympic size pool, measures 12.50 x 25 meters. Water to overflow on the long side for helping the entry and the exit of the dogs in the water.
- **Disc Dog (field outside the village, opposite the main entrance located approximately 200 meters)**
Measures: 104.70 m. x 66.80 m. Natural grass. Fenced.
- **Mobility Dog (external field, in the plan of the Village marked with the letter E)**
Measures 19 x 32 meters. Fenced and lighted paved with "Spontex". Its flexibility assures quality and safety.
- **Palace**
The finals of all disciplines (except swimming) will be played inside the Palace. The field for races inside the Palace measures 25 x 47 meters. The whole area will be covered with carpets. The Palace can contain about 3000 spectators. The building has locker rooms for athletes, stage for awards ceremony, video projection, press area, bar service.

EVENTS (SEMINARS)

For all members of the races and the first guide the access to seminars program is free, except for the course SCIVAC (scheduled on Saturday, October 16, 2010).

For accompanying persons (after the first), visitors and guests the access to seminars requires the buying of a ticket.

PRIZES and AWARDS

The Organizing Committee has established a prize for each discipline, in accordance with sponsorship proposals. The prizes were divided as follows:

The awards for all classes will be held at the end of the races on Friday and Saturday. **Elite class** for the award ceremony will take place at the palace after the dispute of the finals on Sunday, October 17.

Open classes will be rewarded a special medal CSEN Gold - Silver - Bronze

Elite classes will be rewarded with a medal specially minted for Dog Olympic Games®: Gold - Silver - Bronze

Among all participants during the award ceremony will be drawn a gratis trip for 7 days for two people

The title that will be awarded for each discipline (apart from the valid certificate for the Italian league CSEN) is:

- 1st place in class Elite "Absolute Champion Dog Olympic Games® 2010"

The Elite class of each discipline will also have a prize in money:

- € 500,00 winner - Gold medal
- € 300,00 seconds place - Silver medal
- € 200,00 third place - Bronze medal

The prize money will be allocated by the Organizing Committee, where the discipline will be enrolled at least 30 handler entered.

COMPETITION RULES

Each discipline has its own rules, everyone is begged to respect and observe the rules of this Regulations.

1. At the arrival, participants will receive for each dog inscribed a numbered pectoral that must be visible during the race. The number will correspond to that indicated in the catalogue.
2. The dogs will be judged strictly following the catalogue order.
3. Dogs must be ready for racing at the time indicated in the program.
4. Is obligatory for all dogs in the race to stay at the village for the duration of the shift they participate.
5. Is possible the early withdrawal of a dog after the payment of a caution determined by the organizing committee, published in the catalog, that not exceed the registration fee.
6. A judge can not participate in race with his personal dog.

Judges

- they can not consult the catalogue of the event before or during his judgments. No member of the organizing committee will take the catalogue to the court before the end of the event.
- They are not allowed to smoke in the ring during the trial.
- They are not allowed to drink alcohol in the ring.

- They are not allowed to be familiar with tendering or stay with them if they have to judge their dogs. Is authorized to do these things only after the end of the event.
- at the closing date they will be informed of the number of dogs inscribed in the discipline: than they must give their approval and they can require a reserve judge.
- They are the only responsible for the proceedings in the ring. The “Commissioner of ring” is responsible of organizational problems. However, no activity can be decided without the agreement of the judge.

As already noted, a judge must always be assisted in his work in the ring at least by one Commissioner ring (or stewards) decided by the organizers.

The Commissioner must be fluent in the language chosen by the court: Italian or English.

A Commissioner must have good knowledge of the Rules of CSEN disciplines.

A Commissioner must perform the following tasks:

- 1) Group dogs per class.
- 2) Check the absentees in each class.
- 3) Notify the judge of any change or irregular markings.
- 4) Write the report when required.
- 5) Follow the instructions of the judge.

The Commissioner ring must perform the following tasks:

- 1) Collect the dogs per class;
- 2) Check for missing class;
- 3) Report to the judge any change of tenant;
- 4) Write the opinion of the judge when is required;
- 5) Compile the “CSEN book of the dog” and provide, at the end of the race, all the material needed by the organization ;
- 6) contact the organizer's delegate for any problem.

All decisions of the court about classification and assignment of licenses are final, unless the court has acted contrary to the regulation.

Complaints

A Council is established within the Technical Committee of the Village for deciding on any complaints that may be presented during the event. The Council will consists of three persons of the Organization and a technical coordinator for each discipline. The Council will meets within 2 hours after the filling of the complaint.

Complaints of any nature, shall be written and shall be paid with a caution. If the claim is rejected, the caution will remain to the Organization of the event.

In any case, the Organization reserves the right:

- a) to monitor the conduction of the event to ensure the regularity and strict observance of the Rules;

- b) take all measures necessary to improve the performance of the event and the spirit of the Regulation;
- c) to decide in case of complaints;
- d) to verify, in case of disputes, the identity of the dogs, owners and drivers;
- e) to suspend the awards and the publication of the rankings in all cases in which irregularities appear.

Those who want to complain about this Regulation or for discipline, must do so by writing and by signing the complaint that will be delivered to the Secretary of the event by sending the amount of € 250,00.

The right to complain is due only for those who will inscribe their dogs: they have the obligation to produce evidence of their complaint.

Are not eligible claims on the verdict of the judges who, technically, is unquestionable.

Therefore, these claims will be rejected immediately, apart from the claims related to irregularities of the regulation.

The Organization has the right and duty to intervene, even without having been complaining whenever irregularities or infringements of this Regulation.

The supervisory staff and volunteers are also responsible to control the behavior of competitors, judges and the public that attends the event.

Responsibility

The Organization of the event will take all appropriate and better provisions for the proper treatment and safety of dogs present. However, they don't take any responsibility for damage, disease, escape, death or theft of dogs, bites inflicted by them or received etc.. and this applies to any case or cause. Competitors are solely responsible for the bites or other damage caused by their dogs to third parties in the event: as for the simple fact of registration of their dog, the competitors themselves accept these responsibilities.

Responsibilities of participants and the Public

Dog owners and their representatives, all those who have dogs in the race and anyone relate with dogs competing in the event have the greatest respect and deference to the judges, members of the organizing committee and the other competitors, under penalty of exclusion from the event.

Participants should strictly abide by the provisions of this Regulation and the Organisers.

Punctuality is a must not only regulate, but education and sportsmanship. Those who delayed the race appear when called are excluded.

Is forbidden anyone to make comments or complaints to the courts. Who believes that he has reason to make complaints or claims against them, may do so in the manner prescribed by regulation.

Anyone who publicly pronounce words offensive to judges or other competitors or refuses to submit to a decision of the first or the personnel responsible for monitoring, or committing acts of indiscipline will be immediately suspended by the current exhibition, expelled or removed.
